The Sierra Leone Local Content Agency Act 2016 was enacted in March 2016 by H. E President Ernest Bai Koroma. The Act established the Local Content Agency to provide for the development of the Sierra Leone Local content within a range of sectors of the economy as well as having the mandate to establish a Sierra Leone local content performance reporting and scorecard system.

In accordance with Article 63 and 64 of the Local Content Agency Act, 2016, it is a compliance requirement of the Government of Sierra Leone for companies to report on their local content performance using the Agency’s online platform. The Agency is pleased to announce that 10 of the 12 companies participating in the 1st wave of reporting are now **fully compliant** with the requirement to submit their Local Content performance for Q1 and Q2 2016 using the online platform. The Agency wishes to congratulate these 10 companies.

The Agency looks forward to submission of Q3 and Q4 data in due course, and to data being submitted by a 2nd wave of participating companies. The 2016 data is being used to inform government and companies on their current successes and on the future opportunities to develop local content in workforce and procurement. From 2017 onwards, individual company Scorecards will be generated, in accordance with the 2016 Act.
