

## STATUS OF COMPANY REPORTING ON LOCAL CONTENT

The table below is updated monthly. It provides a summary of the status of companies with regards to their compliance with Articles 63 and 64 of the Sierra Leone Local Content Agency Act 2016 to provide data to the Sierra Leone authorities to track local content performance. Companies who have completed all data submissions to the satisfaction of the Local Content Agency are indicated in **green**. Companies who have started to enter data but not yet fully completed are colored in **amber**. Companies who have not yet started are colored **red**. There are three sets of local content performance data required of companies, indicated in the table as follows:

- **WF = Workforce** (Sierra Leone citizens in different job positions)
- **PC = Procurement by Company** (expenditure with Sierra Leone suppliers and on Sierra Leone goods and services)
- **CD = Capacity Development** (training hours received by Sierra Leone citizens, support for Sierra Leone suppliers, investments in training and support for tertiary and vocational institutions)
